This month, ISRN reaffirmed its dedication to water conservation and sustainable resource management. Building upon its recognition at India Water Week 2024, ISRN continues to foster strategic collaborations with national institutions to shape the agenda for India International Water Week 2026.

Through the Pre-COP30 Consultation co-hosted with Paryavaran Sanrakshan Gatividhi, YOJAK, and IIFT, ISRN played a central role in aligning Bharat's climate priorities ahead of COP30. The discussions emphasized climate resilience, adaptation, and collective action, marking a strong example of India's leadership on the global stage

I am delighted to also share that ISRN was honored with the prestigious CSR'25 'Pankh' Award for our MOMENTUM Routine Immunization Transformation and Equity Project across five North-Eastern states. This recognition underscores ISRN's dedication to equitable and inclusive healthcare for all.

In partnership with ISDM, MP-JAP, NSE, and CyberPeace Foundation, ISRN organized workshops on DataShakti, Cyber Security, and the Social Stock Exchange awareness in Bhopal. Over 125 grassroots leaders were trained on data management, cyber hygiene, and innovative fundraising models for social sustainability. ISRN's workshops underscored the importance of understanding India's cyber laws, protecting personal data, and strengthening local institutions to ensure a secure digital ecosystem.

Collaborating with CSIR-NIScPR, Vibha Vani, and Vijnana Bharati, ISRN co-organized a CSR Meet and Capacity Building Workshop focused on integrating science, technology, and social impact for sustainable development.

The Uttam School Project in Ballia, Uttar Pradesh, supported by IRCTC, achieved new milestones with infrastructure upgrades, digital learning facilities, sanitation blocks, and sports amenities creating a model of joyful, holistic education. Through the Swasth Jeevan Express - Mobile Medical Unit, supported by CONCOR India, ISRN extended healthcare services to over 1,500 patients in flood-affected villages, providing diagnosis, medicines, and health education with compassion.

This month ISRN also adding value to its work signed a prestigious Memorandum of Understanding with the Council for Social Development (CSD), combining strengths in research, training, and policy advocacy to co-create initiatives for inclusive and sustainable growth. In September, ISRN launched its new sub theme series under the NGO Clinic Podcast titled the Cyber Security Empowerment Program featuring Major Vineet Kumar of the CyberPeace Foundation. The first episode, 'The Anatomy of a Cybercrime,' offers practical insights to help citizens stay safe online.

WORKSHOPS ON ISDM DATASHAKTI, CYBER SECURITY AWARENESS, AND NSE'S SOCIAL STOCK EXCHANGE BUILD GRASSROOTS CAPACITY IN BHOPAL

Bhopal, 12th September 2025:

The Indian Social Responsibility Network (ISRN), in partnership with ISDM DataShakti, Madhya Pradesh Jan Abhiyaan Parishad (MP-JAP), National Stock Exchange and Cyberpeace Foundation, organized a one-day program in Bhopal on "ISDM DataShakti for Social Impact, Cyber Security Awareness, and National Stock Exchange's (NSE's) Social Stock Exchange (SSE) Platform Workshop" The initiative aimed to equip grassroots leaders with essential knowledge in data management, digital safety, and sustainable financing for social organizations.

A total of 125 participants actively took part in the workshops, representing a diverse range of organizations. Of these, more than 80 organizations were based in Madhya Pradesh, while the remaining participants came from neighbouring states, reflecting strong regional engagement and interest in the subjects discussed.

The event began with an inaugural session attended by Shri Mohan Nagar Ji, Vice Chairman of MP-JAP, who served as the Chief Guest, along with Dr. Bakul Lad Ji, Executive Director of MP-JAP; Shri Yogesh Choudhary Ji (IPS), ADG, MP Police, Bhopal; Shri Santosh Gupta, CEO of ISRN; and Representatives from ISDM.

Welcoming the delegates ISRN Associate Director Mr. Ashish Mansharamani addressed the audience and briefed them about the day's agenda, and connected the work with the spirit of Buddha for developing the social welfare spirit uniting the delegates for working towards a common goal of data management, cybersecurity challenges, fundraising via NSE SSE. Thereafter ISRN CEO Mr. Santosh Gupta gave the context of holding the workshop in the current scenario of cyber challenges and handling data discreetly. Mr. Santosh Gupta also urged participants to support and sensitize their communities — especially senior citizens, homemakers, and vulnerable groups — about cybercrime. He emphasized that voluntary organizations play a pivotal role in promoting data and cyber security and should integrate the components trained on that day into their programs to build awareness and empower cyber

volunteers.

In his address, VC MPJAP Shri Mohan Nagar emphasized that in the digital era, grassroots leadership must be empowered with tools to manage data responsibly, ensure cyber safety, and explore new financial opportunities.

In his address, Dr. Bakul Lad Ji reaffirmed MPJAP's commitment to taking the issues of cyber security and data safety to the grassroots level. He assured participants that the organization will actively work to raise awareness and build digital resilience among all sections of society across Madhya Pradesh, ensuring that even the most remote communities are informed, equipped, and protected in the digital age.

During his speech, Shri Yogesh Choudhary shared insights from his tenure as ADG Cyber and ADG in the Special Branch, highlighting the basic precautions individuals should take in their daily lives to stay safe online.

The first workshop, "The Power of Data for Impact," led by ISDM experts Ms. Mallika Luthra and Mr. Siddharth Dhote, introduced participants to the Data Maturity Assessment. The session demonstrated how the DataShakti platform can help organizations leverage SDG-related datasets for improved decision-making and enhanced social impact.





The second workshop, "The Anatomy of a CyberCrime," addressed India's increasing digital security challenges. Cyber and Legal Security experts Er. Yash Deep Chaturvedi, Ms. Anushka and NLIU Professor Dr. Pooja Kiyawat presented alarming statistics, including India's loss of ₹22,845 crore to cyber fraud in 2024 — a 206% increase over the previous year, with over 22.7 lakh cases reported. The experts stressed the importance of cyber hygiene, awareness of legal protections, and the vital role NGOs play in promoting online safety within communities.

The final workshop on fundraising was conducted by Mr. Kaoshal Kumar, Senior Manager NSE, Mumbai, and Mr. Ashish Mansharamani. They provided a live demonstration of the Social Stock Exchange platform, explaining the registration process, compliance requirements, and the SSE's potential to open new fundraising avenues for financial sustainability for grassroots organizations.

The program concluded with a certificate distribution ceremony led by Dr. Bakul Lad and Shri Santosh Gupta. During his closing remarks, Shri Santosh Gupta stated that "Data is today's new currency, cyber security is both a moral and social duty, and financial innovations such as the SSE are essential to strengthening civil society."



Through this initiative, ISRN and its partners reaffirmed their commitment to building digitally secure, data-driven, and financially resilient grassroots leadership for inclusive development.

CYBER SAFETY AND THE LAW: LESSONS FROM BHOPAL

The rapid rise of digital payments, Aadhaar-linked services, and e-governance has brought both opportunities and risks. As more citizens move online, cybercrimes—from identity theft and online fraud to hacking and harassment—are becoming common. A recent JAP-ISRN workshop on Data Management and Cyber Safety highlighted how grassroots leaders can safeguard their communities by understanding cyber laws and applying simple security measures.



Why Cyber Law Matters

India's Information Technology Act, 2000 and the Digital Personal Data Protection Act, 2023 provide the foundation for a secure digital ecosystem. These laws ensure that:

- Technology misuse such as fraud or hacking is punishable.
- Citizens' rights—particularly the Right to Privacy under Article 21—are protected.
- Officials handling sensitive data like Aadhaar, pension, and ration card records are responsible custodians of privacy.

The Bhopal Case Study

In Bhopal, a group of elderly pensioners became victims of a cyber fraud where their Aadhaar-linked bank accounts were siphoned off. Fraudsters had obtained their details through casual sharing of data by local agents on WhatsApp groups. When complaints reached the police, it was discovered that officials had not implemented basic safeguards like password protection and restricted database access.

Lessons:

- Data collected for governance must never be shared informally.
- Awareness at the grassroots is critical—villagers must be trained to recognize phishing calls, fake OTP requests, and fraudulent loan offers.

Steps Forward for Local Governance

Level	Actions
Individual Officer	Use strong passwords, enable 2FA, and avoid personal devices for official data.
Panchayat/Block	Conduct awareness sessions, secure systems with antivirus and firewalls.
District/Department	Appoint nodal officer, report breaches to cyber police, and maintain backups.

What NGOs Can Do in Communities

NGOs play a vital role in spreading digital awareness at the grassroots level. Some practical steps include:

- Organize community workshops on safe digital practices and common fraud schemes.
- Use role-play or street theatre to demonstrate phishing, OTP fraud, and fake loan traps.
- Create simple handouts in local languages on cyber hygiene practices.
- Partner with schools, SHGs, and youth clubs to build long-term awareness.
- Provide helpline contacts for reporting suspicious activities.
- Work with local police cyber cells to conduct awareness drives.

Cybercrime is not just a technical issue—it is a governance and community safety challenge. As the Bhopal case shows, vigilance, legal awareness, and preventive practices can turn vulnerable citizens into empowered digital users.

Grassroots leaders and NGOs must champion these practices to create a safe digital future.

UTTAM SCHOOL

TRANSFORMING RURAL EDUCATION THROUGH INFRASTRUCTURE & INNOVATION

September 2025 was a month of remarkable transformation at **Composite Vidyalaya**, **Dighar in Ballia district of Uttar Pradesh**, as the Uttam School Project moved closer to shaping a safe, inclusive, and inspiring learning environment for every child and teacher. With each brick laid and each system upgraded, ISRN continues to bring smiles, comfort, and hope to the school community.

1. BOUNDARY WALL AND GATE INSTALLATION - ENSURING SAFETY & STRUCTURE

A **strong 740 ft boundary** wall now encircles the school - built with high-quality precast concrete to ensure safety, durability, and structure.

Two new gates welcome everyone with pride:

- Main Gate (13 ft × 7 ft): A sturdy mild steel gate with anti-rust coating and a nameplate that
 reflects the school's identity.
- Mini Gate (5 ft × 7 ft): Positioned on the north side for smoother and safer student access.

An **interlocking brick pathway** (13 ft × 15 ft) now leads to the main gate, adding beauty and order to the school's entrance.





2. SANITATION BLOCK - PROMOTING HYGIENE & DIGNITY

To address earlier inadequacies, ISRN initiated the construction of a **modern sanitation block**, **now 80% complete.**

The new facility includes:

- 3 Indian WCs and 3 urinals
- Anti-skid ceramic flooring, weatherproof paint and RCC roofing
- Dual 2,000 L soak pits/septic tanks for efficient wastewater managemen

Once completed, this will provide safe, hygienic, and dignified facilities for both students and teachers.





3. ROOF WATERPROOFING - PROTECTING CLASSROOMS & INFRASTRUCTURE

No more leaky roofs! A comprehensive waterproofing treatment across 4,800 sq. ft. has safeguarded the classrooms, ensuring comfort, longevity, and protection for the building during every season.





4. DRINKING WATER FACILITY - CLEAN WATER, HEALTHY MINDS

A new drinking water platform with tiled finishing has been completed, featuring:

- **5 taps** for students and staff
- A 1,000 L water tank for continuous supply
- Additional taps for utensil washing and tree watering
- A smart wastewater diversion system for irrigation and groundwater recharge

This small but powerful upgrade ensures clean, accessible, and eco-friendly water facilities on

campus.



5. BADMINTON COURT - ENCOURAGING PHYSICAL FITNESS

Sports are vital for learning beyond the classroom. The 34 ft × 17 ft badminton court, now 80% complete, features a robust M-25 concrete base and steel net poles. Soon, students will have a dedicated space for fitness, teamwork, and fun!



6. DIGITAL LEARNING LAB - ENABLING SMART EDUCATION

Under the digital transformation initiative, a modern computer lab is being established in a renovated hall..

Completed works include:

- Full civil renovation and waterproofing
- Electrical wiring and installation for power access
- Delivery of furniture and computer systems

Final touch-ups are in progress, with the lab set to be inaugurated next month, empowering students with digital literacy and e-learning opportunities.

7. FLAG POST & CHABUTRA CONSTRUCTION - FOSTERING PRIDE AND OUTDOOR LEARNING

A newly installed flag post now stands tall for students to gather and celebrate national festivals with pride.

Beneath the shade of a Peepal tree, a **15 ft × 15 ft chabutra** now provides a peaceful space for reading circles and group learning — a beautiful blend of **nature and education**.



8. WHAT'S NEXT?

The journey continues with more exciting developments ahead:

- Completion and inauguration of the toilet block and computer lab
- BALA (Building as Learning Aid) painting on gates and boundary walls
- Health & hygiene awareness sessions for students
- Teacher orientation for computer-based learning modules

TOGETHER FOR CHANGE

SWASTH JEEVAN EXPRESS (MOBILE MEDICAL UNIT)

REACHING RURAL LIVES WITH COMPASSIONATE CARE

The Swasth Jeevan Express – Mobile Medical Unit (MMU), supported under the CSR initiative of CONCOR India, continued its dedicated healthcare outreach across Ballia district of Uttar Pradesh, throughout September 2025. Over the month, 25 medical camps were organized, providing healthcare services to 1,558 patients including 777 males and 778 females.

In addition, 16 health awareness activities and 290 diagnostic tests were conducted, ensuring

both preventive and curative care for rural communities.

SPECIAL MULTI-SPECIALTY CAMP

In the midst of recent floods, ISRN successfully organized a **Multi-Specialty Health Camp** at Ramnath Pathak Inter College, Murarpatti, Lalgani, Uttar Pradesh on 28th September 2025.

Over 300 patients received free consultations across multiple specialties-general physician, ophthalmology (50+ free spectacles distributed!), gynecology and orthopedics, along with essential lab tests and medicines. Our dedicated team mobilized nearby flood-affected villages to ensure that healthcare reached those who needed it the most.

From timely diagnosis and lab tests to free medicines and referrals, the camp aimed to provide holistic care, instill hope and ensure well-being for every patient. Seeing smiles return to the faces of women, elders and children reminded us why this work matters so deeply.



HEALTH INSIGHTS

The most common health concerns recorded were **general weakness**, **gastric issues**, **and back pain**, reflecting nutrition-related challenges in the community. The MMU team provided **counselling and health education**, emphasizing better dietary and lifestyle practices for long-term wellness.





HEALTH INSIGHTS

- Non-Communicable Diseases (NCDs): 146 cases (Hypertension, Diabetes, Anaemia)
- Women's Health Issues: 160 cases (Menstrual, Pregnancy-related, Other)
- Seasonal/Infectious Diseases: 1,159 cases (Fever, Malaria, Skin, Waterborne infections)
- Geriatric Health: 975 cases (Arthritis, Weakness, Others)
- Child Health: 52 cases

The MMU continues to bring quality, accessible healthcare to underserved regions. With continuous community mobilization and CSR support from CONCOR India, ISRN remains committed to improving the health and resilience of rural populations.

FORMATION & PROMOTION OF FARMER PRODUCER ORGANIZATIONS (FPOs)

DISTRICT OFFICIALS VISIT INWAANYAN NAGRI ORGANIC FPO IN LAKHIMPUR KHERI

Senior district officials visited one of the ISRN promoted FPO - Inwaanyan Nagri Organic Farmers Producer Company Limited formed in Kumbhi Gola block in Lakhimpur Kheri, Uttar Pradesh on 9th September 2025 to review its operations and assess its contribution to farmers' welfare and rural development.

The inspection team, comprising the Chief Development Officer (CDO), Block Development Officer (BDO), officials from the National Rural Livelihood Mission (NRLM) and representatives from the Department of Agriculture, interacted with the FPO's Board of Directors and reviewed its ongoing initiatives in input supply, produce aggregation and market linkage.



Officials FPO's efforts appreciated the empowering and marginal farmers, small enhancing transparency and promoting collective farming practices. They commended its contribution to improving farmer incomes and strengthening the rural economy.

The NRLM team assured continued support through training and capacity-building initiatives, while officials from the Agriculture Department discussed avenues for technical collaboration.

In the first episode of ISRN's Cyber Security Empowerment Program, Major Vineet Kumar, Cyber Security Expert and Founder & Global President, CyberPeace Foundation, joins Mr. Santosh Gupta, CEO, ISRN, for an insightful discussion on the growing landscape of cybercrime in India. Together, they explore how individuals from all walks of life — students, homemakers, elders, small business owners and other community members can safeguard themselves in the digital





Key Highlights:

- Understanding the hidden traps of phishing links, fake job offers, and digital arrest scams.
- Why oversharing personal details like selfies, birthdays or locations increases vulnerability.
