## ISRN CEO's Field Visit to Uttam School

Mr. Santosh Gupta, CEO of ISRN along with the team, conducted a routine site tour and detailed progress analysis of 2 Model Schools in Himachal Pradesh.

Under the ISRN Uttam School Program, Govt. Primary School, Malpur, Baddi, and Govt Primary and High School, Banne Di Hatti, in Himachal Pradesh, have been equipped with modern educational facilities such as smart class technology, sanitation and toilet facilities, safe drinking water, solar panels, digital library accessibility, sports facilities such as badminton courts as well as deeply engaging visual learning tools.

# **MOMENTUM Routine Immunization Transformation and Equity Project:**

Indian Social Responsibility Network is working with USAID on MOMENTUM Routine Immunization Transformation and Equity project, to amplify the immunization coverage and the government's immunization drive in Nagaland, Meghalaya and Tripura. Despite prevalent misconceptions and myths, the team achieved significant outreach by engaging 8,448 individuals through various community mobilization and awareness initiatives, such as Community/Group meetings, house-to-house visits, IPC, Miking, and Baby Show, to name a few. So far, the team has successfully administered over 1.75 lakh doses of the COVID-19 vaccines to eligible beneficiaries. Additionally, they have supported 152 RI session sites in the month of April'24, administering 4,904 doses and ensuring that 145 children received full immunization.

## Success Story: Enhancing Routine Immunization through Engaging FLWs in Meghalaya

In an effort to enhance Routine Immunization (RI) in Meghalaya, a series of training programs was conducted for the Field level Workers (FLWs) ,ASHAs and ANMs from all the Urban Health facilities at DMHO conference hall, during April'24. Through the trainings witnessed the participation of all over 200+ FLWs.

The FLWs engagement was emphasized due to its pivotal role in promoting, adopting, and maintaining positive practices related to RI. The presence and role of the FLWs consisting of ASHAs and ANMs were identified as valuable for building partnerships and connecting with communities, forming robust bridges between service delivery and the people. Frontline Workers (FLWs), act as crucial conduits for disseminating accurate information and fostering community mobilization. The training aimed to empower the FLWs members with knowledge and skills necessary for promoting, adopting, and maintaining positive immunization practices within their communities. Additionally it also aimed to improve immunization coverage, particularly among vulnerable and marginalized populations in urban areas.





The primary objectives of the training were two foldi) to orient the FLWs on their roles and responsibilities in contributing to Routine Immunization, and ii) to provide insight into the National Immunization Schedule (NIS) and Vaccine Preventable Diseases (VPDs).

During the training sessions which was conducted by RM-JSI Dr. Maj. Dhruba Jyoti Borah, RM-JSI along with the State JSI team and representatives from UNICEF,WHO and UNDP emphasized the proactive leadership role of the FLWs should embody.

The speakers throughout all the sessions stressed the significance of the FLWs in RI sessions and special campaigns like IPPI. The speakers majorly highlighted their role in reducing maternal and child mortality rates. During the sessions, detailed explanation of the NIS, including the importance of administering vaccines in correct sequences, was provided to ensure optimal effectiveness. The speakers also outlined caregivers' responsibilities post-vaccination, including managing events following immunization (AEFI) recognizing its symptoms. A brief discussion on lifestyle-related NCDs was also done emphasized the importance of preventive measures.

The detailed orientation on the FLWs roles and responsibilities, coupled with in-depth discussions equipped the participants with comprehensive knowledge on RI and NIS. Through this training, the critical role of community engagement, particularly through organizations like MAS, in strengthening routine immunization efforts was highlighted. By empowering local stakeholders with knowledge and skills, sustainable improvements in immunization coverage and health outcomes can be achieved, contributing to the overall well-being of communities in Meghalaya



#### SUCCESS STORY: BABY SHOW PROGRAM

On April 24th, 2024, a Baby Show event was organized, attended by Dr. Rio Dy, Director of the UIP Directorate of Health & Family Welfare, Dr. Khrievilhou Nakhro, DPO of UIP/RCH, Dr. John, Chairman of the UPHC Management Committee, Er. Medoseho Sothu, Chairman of Porterlane Colony GB's, Miss Kaheli Chophy, Cause Ambassador, Nagaland, representatives from UNICEF & Vitamin Angel, caregivers, MAS members and healthcare workers. Following the program, a special RI Session was also organized.

The Baby Show program was meticulously planned a prior, week initiating community mobilization immediately thereafter. Activities included checking the health unit's tracking bag, collecting MCP card counterfoils, and contacting all eligible, drop-out, and missed beneficiaries. House-to-house IPC sessions were conducted, engaging with PRI leaders and MAS members to mobilize communities. With these preparations completed, the Baby Show proceeded successfully. Three FIC children who completed their full immunization on time, were honored, and a RI session followed, vaccinating nine beneficiaries.

During the event, the Colony Chairman commended the M-RITE team for prioritizing the health center and ensuring beneficiaries accessed immunization services. He encouraged attendees to motivate their neighbors who hadn't received vaccines to avail themselves of this free and safe opportunity







### SUCCESS STORY: COMMUNITY AWARENESS AND HEALTH CAMP





The RI Health Camp held at Agartala Puranigam UPHC was a significant initiative aimed at promoting health awareness and providing essential healthcare services to the community. Organized by the ISRN Tripura team the camp brought together healthcare professionals and members of the community to address various health-related issues and offer support to those in need. The objective of this camp was to raise awareness about the importance of health and wellprovide basic healthcare services being, underserved communities, screen individuals for common health conditions and also

educate participants on preventive measures and healthy lifestyle choices. A team of medical professionals conducted screenings for various health parameters such as blood pressure, blood sugar levels, BMI (Body Mass Index) etc. Participants had the opportunity to consult with doctors and healthcare providers regarding their health concerns and receive personalized advice. Vaccination services were provided to children and were up to date with their immunizations. The RI Health Camp served as a valuable platform for promoting health awareness, providing essential healthcare services, and fostering community well-being.

## Stakeholders Consultation Workshop on solar panel and agricultural practices

The ISRN Promoted Farmer Producer Organization (FPO) members and farmers recently participated in a transformative workshop aimed at exploring innovative solutions at the intersection of agriculture and renewable energy. Hosted by the World Bank in collaboration with the India Agrivoltaics Alliance (Bhartiya Soar Krishi Sanghatan) at Hotel Fairfield by Marriott, the workshop delved into the potential of solar panel-related pilot projects to revolutionize agricultural practices and enhance income generation. By fostering collaboration and knowledge-sharing, this workshop marks a pivotal step towards sustainable development and resilience in the agricultural sector.
